The concept of essential medicines was pioneered by the WORLD HEALTH ORGANIZATION (WHO) in 1977 with the introduction of the first essential medicines list.

Essential medicines are those that satisfy the basic health care needs of the population of the country, especially in rural area.

The WHO EML (Essential Medicine List) has gained widespread acceptance among nations with 4 out of 5 countries having adopted a national list based on the WHO EML. The list is now considered a cornerstone of national medicine policies. Some countries have provincial or state lists, in addition to the national list.

The concept of essential medicines has also been adopted by many international organizations, such as United Children's Funds (UNICEF), Office of the United Nation High Commissioner for Refugees (UNHCR).The CMS-ED programme based on WHO's Essential Drugs for Primary Health Care.

Scope of CMS & ED

Nepal ,India, there is a huge deficiency of qualified medical professionals as per the WHO policy doctor patient ratio is 1:1000, while in Nepal, India it is 1:10189. In addition, 80% of the Indian medical professionals serve in our urban population. It shows our semi -urban and rural areas needs more medical professional.

In our country approximately 40% of primary health centres run by without doctors. WHO and Indian Medical Standards. Recent economic

survey report presented in the parliament also states the healthcare in rural areas remained a concern.

All this data shows we have a huge requirement of medical professional especially in semi-urban and rural areas for primary medical care and first aid treatment.

CMS & ED diploma holders are entitled to provide first aid treatment and also become eligible to enter into the health care profession.
